

INVITATION FOR BIDS

The City of Grand Haven will receive Bids for the Harbor Drive Reconstruction Project at the office of the City Clerk, 519 Washington Avenue, Grand Haven, MI, 49417 until 10:00 am local time on Wednesday, April 11, 2018, at which time the Bids received will be publicly opened and read. The Project consists of constructing earthwork, grading, drainage improvements, hot mix asphalt paving, concrete curb and gutter, concrete sidewalks, ADA sidewalk ramps, traffic signal improvements, water main replacement, sanitary sewer replacement, street lighting and related construction.

Bids are invited upon the several unit price items included in the Bid Forms.

Electronic contract documents can be obtained online from the Abonmarche website, found at <http://www.abonmarche.com/bids>. There is no fee for registration on the plan holders list and download of electronic bidding documents. Hard copies are available from ABONMARCHE, 95 W. Main Street, Benton Harbor, Michigan, 49022 (269) 927-2295. The fee for obtaining a hard copy documents is Thirty-five Dollars (\$35.00). An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. General Specifications, description and conditions upon which the bid proposal is to be based are on file for examination at the office of the Engineer, Abonmarche, 95 West Main Street, Benton Harbor, MI 49022.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to the City of Grand Haven will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder.

Attention is called to the fact that not less than the minimum salaries and wages as set forth in the Contract Documents must be paid on this project, and that the Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin.

A mandatory Pre-Bid Meeting will be held at 10:00 am local time on Wednesday, March 28, 2018 local time at the City of Grand Haven City Council Chambers located at 519 Washington Avenue, Grand Haven, MI 49417.

The City of Grand Haven reserves the right to reject any or all Bids or to waive any informality in the bidding. Bids may be held by the City of Grand Haven for a period not to exceed 30 days from the date of the opening of Bids for the purpose of reviewing the Bids and investigating the qualifications of Bidders, prior to awarding of the Contract.
