CITY OF ALLEGAN ROSSMAN PARK IMPROVEMENTS AND PICKLEBALL COURT RENOVATIONS

The City of Allegan is requesting Bids for the construction of the **Rossman Park Improvements and Pickleball Court Renovations**. Bids for the construction of the Project will be received at Allegan City Hall located at 231 Trowbridge Street, Allegan MI 49010 until **December 1, 2023 at 10:00 AM** local time. At that time the Bids received will be publicly opened and read. The project is located at the North and East quadrants of the intersection of Marshall and Fifth Streets in the City of Allegan. The Project includes asphalt parking, concrete sidewalks, pickleball court renovation, the installation of site furnishings and associated work.

Michigan Department of Natural Resources Recreation Passport Grant funding is being used for the project and relevant State or Federal requirements apply. The Contractor and all Sub-Contractors must comply with all requirements of 1976 PA 453 (Elliott-Larsen Civil Rights Act), the 1976 PA 220 (Persons with Disabilities Civil Rights Act), and Executive Directive 2019-09, as amended.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Sealed bids bearing the Project name as well as the name and address of the bidder shall be submitted to Tracy Stull, Grant Administrator at 231 Trowbridge Street, Allegan MI 49010.

No preference will be given to local vendors or contractors. Award of the contract will adhere to State purchasing requirements.

There is no fee for registration on the plan holder's list and download of electronic bidding documents. Hard copies will not be available for this Project.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to the City of Allegan will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of the successful bidder.

No bid shall be withdrawn for a period of ninety (90) days after the scheduled opening without the consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or accept the bid, consistent with law, which best serves the interest of the Owner.
