Town of Hebron – 2022 Community Crossings Road Improvements, Call 1

Sealed Bids for the construction of the 2022 Community Crossings Road Improvements, Call 1 Project will be received by the Town of Hebron – Town Council, 107 N. Main Street, Hebron, IN 46341 until Friday, July 15th, 3 PM Local Time, at which time the Bids received will be publicly opened and read at the Town Hall, 107 N Main Street, Hebron, IN 46341 at 3 PM. The Project consists of approximately 2,365 square yards of full depth road reconstruction, approximately 5,390 square yards of milling and HMA resurface work, sidewalk, curb ramps, and approximately 570 feet of storm sewer improvements and other appurtenant work for 4 streets wholly within the Town of Hebron. Construction to be completed in 2022.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Two (2) copies of the Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to: Jamie Uzelac, Town Clerk, 107 N Main Street, Hebron, IN 46341.

An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. Washington Street, Valparaiso, IN 46383.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder. Bidder shall submit Indiana State Form 96 and be certified to do work in the State of Indiana. Additional Bidding requirements are in the Instructions to bidders included in the Project Documents.

No pre-bid meeting will be held for this project.

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without consent of the Owner. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
