The project consists of HMA removal and paving, HMA crack sealing, HMA sealcoating, and replacement of pavement markings.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Sealed bids bearing the project name as well as the name and address of the bidder shall be submitted to Lake Michigan College (Benton Harbor Campus), 2755 E Napier Ave, Benton Harbor, MI 49022. A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to Lake Michigan College will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder.
