The City of St. Joseph (Owner) is requesting Bids for the construction of the Willa Drive, Lester Avenue, and Donna Drive Reconstruction Project. Bids for the construction of the Project will be received at the City of St. Joseph – City Hall located at 700 Broad Street, St. Joseph, MI 49085, until Tuesday January 18, 2022 at 3:00 pm local time. At that time the Bids received will be publicly opened and read. The bid opening can be accessed virtually using the following link:

The Project includes reconstruction of streets, utilities (water main, sanitary sewer, storm sewer) and associated items. Contract #1 includes work on Willa Drive from St. Joseph Drive to Botham Avenue, Lester Avenue from Niles Avenue to Willa Drive, and water main work on St. Joseph Drive. Contract #2 includes work on Donna Drive from Lakeview Avenue to S. State Street along with minor work on S. State Street.
