**North Liberty Utilities Extension to Potato Creek State Park
Contract 4 Lift Station Rehab and Manhole Lining**

Sealed Bids for the construction of the North Liberty Utilities Extension to Potato Creek State Park Contract 4 Lift Station Rehab and Manhole Lining will be received by the Town of North Liberty, 300 South Main Street PO Box 515, North Liberty, Indiana 46554 until September 18, 2023, 6:00 pm Local Time, at which time the Bids received will be publicly opened and read at the Town Hall, 300 South Main St PO Box 515., North Liberty, Indiana 46554 at 6:00 PM. The Project consists of the rehabilitation of four (4) lift stations and installation of one (1) new lift station, included within the scope of each lift station is the installation of new pumps, control panels, electrical work, site restoration, and all other appurtenant work. Manhole rehabilitation work consists of interior manhole cleaning, interior cementitious lining, exterior grout sealing and all other appurtenant work. The rehabilitation of four (4) lift stations, one (1) new lift station and manhole rehabilitation work consists wholly within Potato Creek State Park.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to Vicki Kitchen, IAMC, MMC, Clerk-Treasurer, 300 S Main Street PO Box 515, North Liberty, Indiana 46554.

Bidding documents will be available on August 21st, 2023. Electronic contract documents can be obtained online from the Abonmarche website, found at <http://www.abonmarche.com/bids>. There is no fee for registration on the plan holder's list and download of electronic bidding documents. Hard copies are available from ABONMARCHE CONSULTANTS, INC., 17 N. Washington Street, Valparaiso, IN 46383. (219) 850-4624. The fee for obtaining a hard copy documents is One Hundred Dollars (\$100.00). An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. General Specifications, description and conditions upon which the bid proposal is to be based are on file for examination at the office of the Engineer, Abonmarche Consultants, Inc. 17 N. Washington Street, Valparaiso, IN 46383.

Bids shall be properly and completely executed on bid proposal form provided, accompanied by a Non-Collusion Affidavit and a Certified Check or Bid Bond payable to the Owner in the amount of not less than five percent (5%) of the bid. Each bid shall include Indiana State Form 96 and all other required forms as described in the bidding documents. Bidder shall be certified to do work in the State of Indiana. Additional Bidding requirements are in the Instructions to bidders included in the Project Documents.

The bidder awarded the contract will be required to furnish a separate Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the contract price before commencing work. The Performance Bond and Payment Bond shall remain in effect throughout the entire construction period. In addition a Warranty Bond in the amount of ten (10%) will be required for a period of three (3) years prior to the final acceptance by the Owner. The project will be financed through the Indiana Finance Authority through the State Revolving Fund. Contractors are required to adhere to Davis Bacon Wage Rates throughout construction.

A non-mandatory Pre-Bid Meeting will be held on September 6th, 2023, at 10:00 AM Local Time, at the North Liberty Town Hall Community Center, 300 S. Main St., North Liberty, Indiana, 46554

No bid shall be withdrawn for a period of ninety (90) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
