Sealed Bids for the construction of the 2021 Community Crossings Road Improvement, Call 2 will be received by the Town of New Chicago – Town Council, 122 Huber Blvd, Hobart, IN 46342, until February 23rd 2022, 3PM Local Time, at which time the Bids received will be publicly opened and read at the Town Hall, 122 Huber Blvd, Hobart, IN 46342. The Project consists of 4-inch mill and fill, striping, replacing of Storm Water piping, installation of structures including storm water manhole and other appurtenant work for four (4) streets wholly within the Town of New Chicago.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Two (2) copies of the Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to: Town of New Chicago, Town Hall, 122 Huber Blvd., Hobart, IN 46342.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder. Bidder shall submit Indiana State Form 96 and be certified to do work in the State of Indiana. Additional Bidding requirements are in the Instructions to bidders included in the Project Documents.

There will be no pre-bid meeting for this project.

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
