Sealed Bids for the construction of the 2024 Community Crossings Road Improvement, Call 1 will be received by the Town of Pines – Town Council, 1519 Delaware Ave, Michigan City, IN 46360 until May 23, 4 PM Local Time, at which time the Bids received will be publicly opened and read at the Pines Town Hall, 1519 Delaware Ave, Michigan City, IN 46360. The Project consists of 2-inch mill and fill, striping, and other appurtenant work for eight (8) street segments wholly within the Town of Pines.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Two (2) copies of the Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to: Town of Pines, Town Hall, 1519 Delaware Ave, Michigan City, IN 46360.

An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. Washington Street, Valparaiso, IN 46383.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder. Bidder shall submit Indiana State Form 96 and be certified to do work in the State of Indiana. Additional Bidding requirements are in the Instructions to bidders included in the Project Documents.

There will be no pre-bid meeting for this project.

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
