CONTRACT 1

The project consists of HMA removal and paving, HMA crack sealing, HMA sealcoating, and replacement of pavement markings.

CONTRACT 2

The project consists of milling and resurfacing, along with some minor bridge repairs to be performed on B-Wing and C-Wing bridges prior to HMA resurfacing work.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Sealed bids bearing the project name, "2022 Asphalt Repairs Contract 1 Project", "2022 Asphalt Repairs Contract 2 Project", as well as the name and address of the bidder shall be submitted to Lake Michigan College (Benton Harbor Campus), 2755 E Napier Ave, Benton Harbor, MI 49022. Bids are to be delivered to the campus mailroom in the Main Building, attention Sara VanderVeen.

There is no fee for registration on the plan holder's list and download of electronic bidding documents. Hard copies are available from ABONMARCHE, 95 W. An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. General Specifications, description and conditions upon which the bid proposal is to be based are on file for examination at the office of the Engineer, Abonmarche, 95 West Main Street, Benton Harbor, MI 49022.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to Lake Michigan College will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder.

No bid shall be withdrawn for a period of ninety (90) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
