The Project includes the following Work: Removal of existing sports field, accessory buildings, pavement, lighting, and other electrical equipment. Construction of new sports field with fencing, lighting and walkways, parking area with curb, asphalt pavement, sidewalk, pavement markings, storage/mechanical shed, open area with driveway circular asphalt turn-around for general public use. Concrete pad for skate park equipment (skate park equipment not in contract). Landscaping, planting, and retaining wall.
