**ADVERTISEMENT FOR BIDS****NOTICE:**

Sealed Bids for the **2023 Water Material Service Investigation Project** will be received by the City of Bangor at said date and time. All Bids received will be publicly opened and read. Bids will be received for a single prime Contract. Bids shall be on a unit price basis. **Sealed bids bearing the project name as well as the name and address of the bidder shall be submitted to: Christina Sanders, City Clerk, City of Bangor, 257 West Monroe Street, Bangor, MI 49013 before the date and time of the listed bid opening.**

**PROJECT DESCRIPTION:**

The project consists of investigating water service locations throughout the City per the Department of Environment, Great Lakes, and Energy (EGLE) Complete System Distribution Material Inventory (CDSMI) guidelines. Inspections include water service potholing at all noted exterior curb stops as well as the main for select locations. The Contractor will be required to upload service material information and photographs into an online geodatabase set up by the engineer.

The bid opening will be held on **June 14, 2023, at 10:00 a.m., local time** at Bangor City Hall, 257 West Monroe Street, Bangor, MI 49013.

**BIDDING INSTRUCTIONS & SECURITY:**

A certified check, cashier's check, or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to the City of Bangor will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder.

No bid shall be withdrawn for a period of ninety (90) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.

This project received funding assistance from a Drinking Water Asset Management (DWAM) grant, relevant state and federal requirements apply. Project must comply with 1976 PA 453 and 1976 PA 220. In addition, the contractor and any subcontractors shall not discriminate against an employee or applicant for employment with respect to hire, tenure, terms, conditions, or privileges of employment, or a matter directly or indirectly related to employment, because of race, color, religion, national origin, age, sex, height, weight, marital status or a disability that is unrelated to the individual's ability to perform the duties of a particular job or position.
