MEC Smart Park Development

Sealed Bids for the MEC Smart Park Development will be received by Midwest Energy and Communications at 60590 Decatur Road, Cassopolis, MI 49031 until 10:00 a.m., local time, on October 20, 2022.

The project includes the construction of utilities (sanitary sewer and forcemain, sanitary lift station, water main, and storm sewer), large retention ponds, 8200 ft of roadway construction, and associated site grading on an approximately 230-acre site. Additional improvements to surrounding MDOT and county roads will also be required.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Sealed bids bearing the project name as well as the name and address of the bidder shall be submitted to Midwest Energy and Communications at 60590 Decatur Road, Cassopolis, MI 49031.

An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. General Specifications, description and conditions upon which the bid proposal is to be based are on file for examination at the office of the Engineer, Abonmarche, 95 West Main Street, Benton Harbor, MI 49022.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid, made payable to Midwest Energy and Communications will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder.

No bid shall be withdrawn for a period of ninety (90) days after the scheduled opening without consent of the OWNER. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
