Town of Burns Harbor – Westport Trail Connection

Sealed Bids for the construction of the 2023 Westport Trail Connection Project will be received by the Town of Burns Harbor – Town Council, 1240 North Boo Road, Burns Harbor, IN 46304 until Friday, February 9th, 2 PM Local Time, at which time the Bids received will be publicly opened and read at the Town Hall, 1240 North Boo Road, Burns Harbor, IN 46304. The Project consists of approximately 1,450 feet of HMA resurface work, topsoil stripping, restoration, and concrete work wholly within the Town of Burns Harbor.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis. Two (2) copies of the Sealed Bids bearing the project name as well as the name and address of the bidder shall be submitted to: Jane Jordan, Town Clerk, 1240 North Boo Road, Burns Harbor, IN 46304.

Bidding documents will be available on January 19th, 2024. Electronic contract documents can be obtained online from the Abonmarche website, found at <http://www.abonmarche.com/bids>. An additional Ten Dollars (\$10.00) will be charged for plans requiring shipping. Washington Street, Valparaiso, IN 46383.

A certified check, cashier's check or bid bond in an amount equal to five percent (5%) of the total amount of the bid will be required with each bid as security for the proper execution of the contract. A 100% Labor, Material, and Performance Bond will be required of successful bidder. Bidder shall submit Indiana State Form 96 and be certified to do work in the State of Indiana. Additional Bidding requirements are in the Instructions to bidders included in the Project Documents.

No pre-bid meeting will be held for this project.

No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening without consent of the Owner. The Owner reserves the right to reject any and all bids, waive any informality in bidding or to accept the bid, consistent with law, which best serves the interest of the Owner.
